TRACK AND FIELD CHAMPIONSHIPS

WHEREAS, Seabury Hall's track and field girls team won the Hawaii High School Athletic Association's 2017 Island Movers State Track and Field Championships on Saturday, May 13, 2017, at Keaau High School in Keaau, Hawaii; and

WHEREAS, the lady Spartan's, in their upset victory over Kaiser High School, earned a team point total of 74 points, 4.5 points more than the second-place finisher; and

WHEREAS, the girls track and field team was led by seniors Ava Shipman and Claire Borthwick along with team members Veronica Winham, Kallalei Ryden, Taysia Pimentel, Darby Mulligan, Erika Preseault, and Ameera Waterford; and

WHEREAS, the lady Spartans won their fifth consecutive Maui Interscholastic League team championship, 40 points ahead of the second-place team; and

WHEREAS, with the support and dedication of Coach Bobby Grossman, the lady Spartans have consistently been a top statewide contender in the sport of track and field, earning their second state team title in four years; and

WHEREAS, senior Ava Shipman won three individual state titles in the 800, 1,500, and 3,000-meter races, aiding the team in capturing the championship title; and

WHEREAS, Shipman ran an outstanding 1,500-meter race with a time of 4:39.45, breaking the state track record of 4:43.53 set in 2012, by fellow Seabury Hall graduate Dakota Grossman; and
